As the cold weather is quickly approaching, please remember to have your fireplace inspected annually. You must provide proof to the office so you are not in jeopardy of receiving a violation notice with a fine attached.

If you do not use your fireplace, a fireplace affidavit can be found on the website in place of an inspection.

You have probably noticed by now three new speed bumps have been installed throughout the community.

People speeding in the community was the deciding factor on the installation of the speed bumps.

Please abide by the posted speed limit signs and slow down when driving in the community!!

Parking - Violation of these rules may result in fines or towing of offending vehicles. Residents are responsible for all towing and storage fees and will be fined for any costs incurred by the Association.

- Parking is limited to two vehicles per unit.
- Garden/Flat residents may use two lined spaces on a first come first served basis.
- All parking must be in lined spaces. Townhouse residents may not use the parking provided for the Garden/Flat units.
- Vehicles may not sit in any one parking space for more than 14 days. Any abandoned vehicle will be towed.

• Driving or parking any vehicle in grassy areas or sidewalks is prohibited. Violators will be fined \$25.00 or the cost of correcting the property damage (whichever is greater) for each violation.

DON'T FEED THE DUCKS, GEESE OR OTHER WILDLIFE

We would like to remind you that the rules and regulations state that you are not to feed the ducks, geese or other wildlife. Some of the negative effects are as follows.

- Lack of balanced diet may cause deformity in goslings, hindering the bird's flight ability.
- Feeding causes overcrowding allowing diseases such as botulism and cholera to spread easily and possibly result in massive waterfowl die-offs.
- Geese lose their fear of humans and become aggressive.
- Feeding reduces the need for geese to migrate they stay in an area longer and create more problems.
- Increased wood damage from squirrels, racoons and opossums.
